

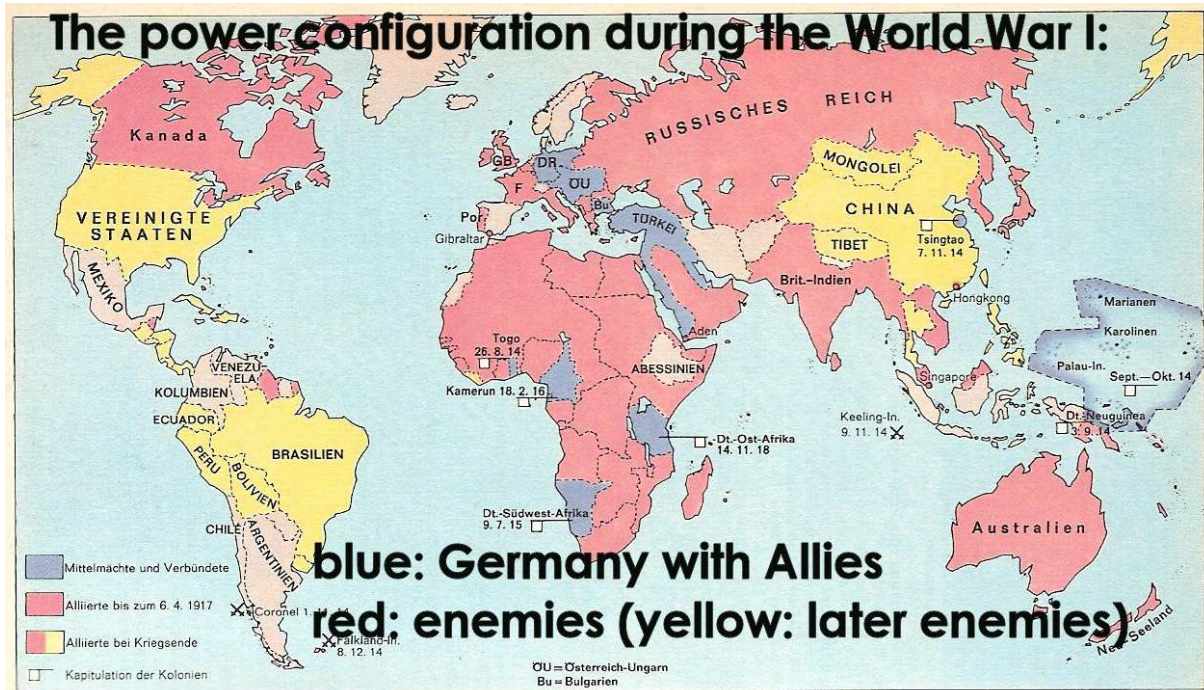


## Seminar held in Hamburg on September 20, 2008 – as well as further topics relating to both historical and present-day events

- 9. 11. 1989: The “Fall of the Berlin Wall”, with disastrous economic consequences for the citizens of the former German Democratic Republic
- 11. 9. 1941: U.S. President Roosevelt, a High-Degree Freemason himself, states publicly that he (– without declaring war –) gave the order to fire on German military vehicles.
- (Comment: Hitler and the NSDAP were deliberately brought to power by Catholicism and Zionism working hand in hand with Masonic Wall Street in order to destroy Germany and the German cultural impulse.)
- 9. 11. 1938: The “Crystal Night” or “Night of the Broken Glass”; the NSDAP attacks Jewish fellow citizens, their synagogues and property – the fruit of the anti-Semitic seeds sown by Freemason and founder of the Thule Society, Rudolf von Sebottendorf.
- 8./9. 11. 1923: “March on the Feldherrnhalle” (Field Marshal’s Hall) – Hitler coup in Munich
- 9. 11. 1918: Revolution and overthrow of the Kaiser in Berlin. Prior to this there had been a Communist revolution in Munich (civil war). Rudolf von Sebottendorf gave a speech in Berlin which already contained the quintessence of “Third Reich ideology”. (By way of explanation: “German Reich ideology”, from 1870 or so onwards, was undoubtedly wrong and gave rise to “Hitler mania”. Johann Wolfgang von Goethe warned that: “The German faces no greater danger than trying to improve himself through or with his neighbours. There is perhaps no other nation more capable of developing out of its own self.” With regard to the founding of the “German Reich”, Friedrich Nietzsche referred to the “extirpation of the German spirit for the sake of the German Reich”.
- On 11. 9. 1897, the British newspaper *The Saturday Review* published an article which included the following statements: “What Bismarck realised, and what we too may soon come to see, is that [...] England is the only Great Power who could fight Germany without tremendous risk and without doubt of the issue. Our work over, we need not even be at pains to alter Bismarck’s words, and to say to France and Russia: Seek some compensation. Take inside Germany whatever you like: you can have it.” The article closed with the words “Germaniam esse delendam” (Germany must be destroyed). This was by no means an exception: The British press had been fuelling anti-German sentiments since 1871.

(Herwig Duschek:) The article closed with the words: “Germaniam esse delendam!” – “Germaniam esse delendam!” This cry could be heard in certain Masonic circles as early as the late 19<sup>th</sup> century. Do you know what this expression means? It means: “Germany must be

destroyed!” And that was why revolutions had to take place in Russia in order to isolate Germany, and why there had to be a First World War and then a Second World War. Hitler was given the necessary financial backing because he was to become the instrument with which to destroy Germany in the long run. We no longer have any German culture here. Germany does not exist anymore: this is now the 52<sup>nd</sup> U.S. state.



(Herwig Duschek:) Rudolf Steiner fought to prevent the signing of the Treaty of Versailles by endeavouring to point out to those in power in Germany why they should not put their signature to what the allies were hoping to achieve via this treaty. It was the Russian tsar who ordered the general mobilisation of his army and when this order was not reversed, Germany had no other choice but to declare war on Russia. The French army, too, was standing ready for action. I will show you pictures afterwards to illustrate the vast amount of intriguing which was going on behind the scenes, the policy of isolation and the so-called “entente cordiale” or “friendly understanding” between states, as it is referred to in the history books.
